When I spoke at Tory Party conference earlier this year, several senior Tories (who I will spare the embarrassment of 'calling out' by naming them) agreed with me that we needed an inquiry into food bank use in the UK.

Several months later, nothing seems to have been done about it. It seems the old adage is true – if you want something done, you should probably do it yourself.

Backed by the Daily Mirror, The Trussell Trust, and Unite, the petition went live today, and in the first 24 hours, over 65,000 people have signed it.

The response has been incredible – but this isn't a one day push. I'm going to keep sharing this petition and campaigning until its taken up as a debate in Parliament – because MPs have ignored this issue for far too long, or tried to pretend that it doesn't exist, or let charities and volunteers pick up the pieces.

An E-Mail sent to The Trussell Trust on a Friday from a young man, who was later referred to Glasgow SE Foodbank:

"Hello, my name is Jamie. I can't believe I am actually doing this. I have two degrees and lost my job back in March when my company went into Administration. I exhausted my savings by June and had to go on Jobseekers Allowance. I earn £67.50 a week on Jobseekers or £270 a month but my monthly bills exceed this. Thankfully I get a little help with housing benefit but when it comes time to cut corners, it's the food or the electric of the gas that gets cut.

I'm relying on my free library membership to send this E-Mail, which brings me to my point. I need to know what food charities are available in the Glasgow area. I haven't eaten since Monday and I can't keep going days on end with no food. I hate having to ask but I don't know what if any alternative there might be short of stealing.

What does a Foodbank look like?

Trussell Trust Foodbanks provide a minimum of three days nutritionally-balanced emergency food relief to individuals and families experiencing hardship in the United Kingdom. The Foodbank is a warm and comfortable but also confidential and discreet environment.

People are referred via voucher by frontline organisations for various reasons including benefit delays / changes, low income and debt and receive assistance to emerge out of crisis towards sustainable living.

The Trussell Trust partners with churches and communities and the goal is for every town and city to have a Foodbank and to see a nation where no one needs to go hungry.
