How can Government and the HE sector encourage more employers to enrol and support their workers in parttime study; to what extent will the move towards a 'right to request flexible working' help facilitate this? Is the development of Higher Apprenticeships, equivalent to a degree, likely to further reduce the number of people studying part-time? Should universities and Government encourage more prospective students aged under 24 to consider studying part-time; what steps can be taken to address the perception of part-time study as being for mature students? How successful has the Access to HE diploma been in improving participation levels amongst adults without the traditional qualifications required for university? What more can Government, universities and other stakeholder groups do to increase the number of mature students, particularly from disadvantaged backgrounds?
